

Advertising Basic Policies Compliance Checklist

Meta (Facebook and Instagram)

Ad Content:

- □ My ads follow Meta's Advertising Standards and Community Standards.
- ☐ My ads comply with all applicable laws and advertising codes.
- ☐ My ads accurately represent my company, product, service, or brand.
- ☐ My ads do not include improper grammar or punctuation.
- My ads do not include sexual content, nudity, or allusions to sexual activity.
- My ads do not reference or imply a user's personal characteristics, including race, ethnicity, religion, beliefs, or sexual orientation.
- ☐ My ads do not discriminate or promote discrimination.
- My ads do not promote misleading or deceptive practices or products.
- My ads do not contain images with non-existent functionality (e.g., a "play" button that doesn't work).
- ☐ My ads do not make potentially misleading claims or set unrealistic expectations.
- ☐ My ads do not include low-quality content (e.g., sensationalized or exaggerated language, withholding key information).
- I am familiar with Meta's policies on Community Standards, Adult Content, Personal Attributes, Discriminatory Practices, Unacceptable Business Practices, Nonexistent Functionality, Unrealistic Outcomes, Misinformation, and Low Quality or Disruptive Content.

Prohibited Products:

- ☐ My ads do not promote the sale or use of adult products/services.
- My ads do not promote tobacco, unsafe supplements, prescription drugs, recreational drugs, or illegal drugs.
- My ads do not promote the sale or use of weapons, ammunition, weapon modification accessories, or explosives.
- If promoting contraceptives, my ads do not focus on sexual pleasure or enhancement and are targeted only at users who are 18 and over.
- I am familiar with Meta's policies on Adult Products or Services, Tobacco and Related Products, Prescription Drugs, Unsafe Supplements, and Weapons, Ammunition, or Explosives.

Google Ads

Prohibited Content:

- ☐ My ads do not promote or incite violence or hatred.
- My ads do not include adult content or services.
- □ For alcohol ads, I adhere to local laws and ensure compliant targeting.
- □ For gambling and gaming, I comply with local regulations.

Restricted Content:

Prohibited Content:
